

INTRODUCTION

The Essex County Commissioners approved original Acceptance, Approval, Insertion resolution R 2022-00724 to accept FY 2023 for July1, 2022 to March 14, 2023.

The New Jersey Governor's Council on Alcohol and Drug Abuse (GCADA) has awarded the Essex County Municipal Alliance a grant in the amount of \$108,201 for participation in the Alliance to Prevent Alcoholism and Drug Abuse DMHAS Youth Leadership Grant Program. Extending the period from July 1, 2022 to March 14, 2023 to July 1, 2022 to June 30, 2023.

The allocation by GCADA to the Essex County Municipal Alliance as described in the letter of Agreement is based on the DHS/Division of Mental Health and Addiction Services (DMHAS) which is funding through federal, SAMHSA funding. The program extension will be valid for three months for the period of March 15, 2023 to June 30, 2023.

The extension for State Fiscal Year (SFY) 2023 to include a four fiscal quarters starting March 15, 2023 and ending June 30, 2023. The SFY 2023 four quarter grant funding is only extension of the period no additional funding from the Municipal Alliance Grant during that period.

DMHAS Youth Leadership Grant was only available to Municipal Alliances that are actively participating in the FY2023 grant. The City of Newark and Township of Essex Fells have ceased participation in the Essex County Municipal Alliance Program. The Township of Cedar Grove, Township of Irvington, Township of Montclair, City of Orange and Township of Verona opted out of the DMHAS Youth Leadership Grant.

RECOMMENDATION

It is recommended that the County of Essex accept, approve, insert, modify and extent the grant allocation into the county budget.

REASON FOR RECOMMENDATION

Acceptance, approval, and insertion of these funds into the county budget will enable the County to coordinate the Essex County Municipal Alliance Program, enable local drug and alcohol prevention and education, provide technical assistance, training, oversight, and monitoring of the programs with the participating alliances until June 30, 2021.

FISCAL IMPACT

Funding is provided by the State of New Jersey Governor's Council on Alcoholism and Drug Abuse (GCADA) through the DHS/Division of Mental Health and Addiction Services (DMHAS) which is funding through federal, SAMHSA funding

ALTERNATIVES

To deny this agreement would deprive the municipalities in the County of Essex the funds to provide Youth Leadership programs on prevention and education of alcohol and drug abuse for youth and caregivers and professional who work with youth.

CONCLUSION

The Essex County Municipal Alliance Program, coordination and DMHAS Youth Leadership program funds are critical in overseeing and maintaining municipal alliance programs, which provide prevention and education activities to the citizens of Essex County of all ages in the area of alcohol and drug abuse.

FY 2023 LETTER OF AGREEMENT
REVISED GRANT TIMELINE

A Letter of Agreement between the Governor's Council on Alcoholism and Drug Abuse and the County of ESSEX for participation in the Alliance to Prevent Alcoholism and Drug Abuse DMHAS Youth Leadership Grant.

The undersigned accepts this Letter of Agreement, Grant and Attachments A, B and C attached herewith to be the Terms and Conditions of grant participation in the Alliance to Prevent Alcoholism and Drug Abuse DMHAS Youth Leadership Grant and the local coordination of said grant.

This Letter of Agreement will remain valid for the period of July 1, 2022 to June 30, 2023 contingent upon full compliance to the stipulations of the Governor's Council on Alcoholism and Drug Abuse Municipal Alliance requirements.

If, through any cause within its control, the county (hereinafter the GRANTEE) shall fail to fulfill in a timely and professional manner the obligations under this agreement, or if the GRANTEE should violate any of the covenants, provisions or stipulations of this Letter of Agreement, the Governor's Council on Alcoholism and Drug Abuse (hereinafter the GCADA) will thereupon have the right to terminate this agreement by written notice to the GRANTEE and specifying the effective date thereof, at least thirty (30) days prior of the termination date.

Funds issued by the COUNCIL to the GRANTEE under this Letter of Agreement shall not exceed \$108,201.00, which is your allocation of the DMHAS Youth Leadership Grant per the GCADA funding formula.
