WHEREAS, no provision has been made in the 2023 Temporary Budget of the County of Essex and,

WHEREAS, the total Emergencies in 2023 pursuant to N.J.S.A. 40A:4-20, including this appropriation is now therefore be it, \$28,905,338.00

INTRODUCTION

The County of Essex was awarded the SCAAP grant by the Bureau of Justice Assistance, US Department of Justice in the amount of \$5,573,544.00 for a requirement of identifying all foreign born confined persons with at least one felony or two misdemeanor convictions for violations of state or local law, and incarcerated for at least 4 consecutive days during the reporting period.

The Department of Justice Reauthorization Act of 2005 (Pub. L. 109-162, Title XI) included the following requirement regarding the use of SCAAP funds: "Amounts appropriated pursuant to the authorization of appropriations in paragraph (5) that are distributed to a State or political subdivision of a State, including a municipality, may be used only for correctional purposes." Beginning with FY 2007 SCAAP awards, SCAAP funds must be used for correctional purposes only.

RECOMMENDATIONS

It is recommended that the Board of Commissioners approve the insertion of these funds into the 2023 County Budget allocated for the Department of Corrections.

REASON FOR RECOMMENDATION

The approval of these funds will allow the Department of Corrections to be recipients of the SCAAP grant by providing the Bureau of Justice with information meeting the criteria described above.

FISCAL IMPACT

There is no fiscal impact or matched funds requirements for the County.

ALTERNATIVE

There are no alternatives for the use of these funds.
