SUBJECT:

DEPARTMENT OF PARKS, RECREATION AND CULTURAL AFFAIRS – CONTRACT AWARD TO BRITTON ELECTRICAL CONTRACTORS, THE LOWEST RESPONSIVE AND RESPONSIBLE BIDDER TO PROVIDE REPAIR OF OUTDOOR ATHLETIC GAME FIELD LIGHTING, SCOREBOARDS, SPECIAL PLAYGROUND LIGHTING AND RELATED CONTROL PANELS – TWENTY-FOUR MONTH CONTRACT – AMOUNT NOT TO EXCEED \$603,754.80

WHEREAS, the County of Essex has a need to have a vendor provide Repair of Outdoor Athletic Game Field Lighting, Scoreboards, Special Playground Lighting and Related Control Panels (the “Services”) for the Department of Parks, Recreation, and Cultural Affairs; and

WHEREAS, the County’s Office of Purchasing has publicly advertised for bids for the Services; and

WHEREAS, the County has received, from two (2) vendors written responses to the aforesaid advertisement for bids; and

WHEREAS, the County’s Office of Purchasing recommends the Board of County Commissioners award the contract for the Services to Britton Electrical Contractors, the lowest responsive and responsible bidder; and

WHEREAS, the Chief Financial Officer has certified that he will further certify the availability of funds to pay the contract when services are ordered (which certification is attached hereto); and

WHEREAS, the New Jersey Public Contracts Law (N.J.S.A. 40a: 11-1 et. seq.) requires that the Board of County Commissioners by resolution approve the awarding of a contract for the provision or performance of any goods or services, the cost of which in the aggregate exceed the statutory bidding threshold; now, therefore, be it.

RESOLVED, by the Essex County Board of County Commissioners:

1. That the award of a Contract for the Services for a twenty-four month period at a cost not to exceed \$603,754.80 to Britton Electrical Contractors, the lowest responsive and responsible bidder, in accordance with the recommendation of the County's Office of Purchasing, be and hereby is approved, and that the County Administrator be and hereby is authorized to enter into and execute said contract as aforesaid together with such other documents incident thereto as may be necessary.

2. That the Clerk of the Board of County Commissioners forward two (2) certified copies of this resolution and agreement to the Office of Purchasing & one to the Department of Parks, Recreation and Cultural Affairs.



**Britton made a slight miscalculation on their bid sheet. They had a total of \$603,754.08. However, the correct total is \$603,754.80. Regardless, Britton is the lowest bidder.*

RECOMMENDATION AND REASONS:

Britton Electric is the lowest responsible bidder. Therefore, Essex County Parks is recommending the contract be awarded to Britton Electric for Bid #23-002. The contract will run for twenty-four (24) months from the date of award. There is also an option for an additional twenty-four (24) months.

FISCAL IMPACT:

The as-needed total contract award is \$603,754.80. Funds for this contract are available from account #01-201-28-370-120-100.
