CONSTANCE LUNDBERG CROWLEY

WHEREAS, Constance Lundberg Crowley of Montclair, New Jersey, is being remembered upon her passing from this life on Friday, February 3, 2023, at the age of 95; and

WHEREAS, Constance Lundberg Crowley was born to Edward A. and Signe Ehnstrom Lundberg in Fitchburg, Massachusetts, in 1927; and

WHEREAS, Constance Lundberg Crowley was a Marine Corps wife, moving her family numerous times as duty called. Each of her five children was born in a different place. She often said that although they did not have a permanent home during her husband Richard's multiple overseas deployments, they had a very exciting life. They spent many years in Virginia and two years in London after her husband's retirement; and

WHEREAS, in 2010, Constance Lundberg Crowley moved to Montclair to live with daughter Connie Keys and her family. She loved the town and its proximity to New York City. She loved Egans, Watchung Booksellers, SLA Thai, Talbots, Eagle Rock, Presby Iris Gardens, Let's Yo, The New York Times, the Montclair Film Festival and the annual Swedish Christmas fair. She liked telling relatives that she was once in physical therapy with Yogi Berra. She was a member of the Montclair Women's Club and the Friends of Barnet book club for more than 10-years; and

WHEREAS, Constance Lundberg Crowley was a loyal FDR, JFK, Barack Obama Democrat and an avid political news follower. She was thrilled to meet Joe Biden, Cory Booker and Mikie Sherrill during her years in New Jersey. She loved the theater and knew (and sang) the lyrics to most Broadway musicals. She loved all things Swedish and was proud to be the granddaughter of immigrants. Most of all, she adored her children, grandchildren and great-grandchildren, reveled in their achievements and inspired them to be their best selves; and

WHEREAS, Constance Lundberg Crowley was predeceased by her husband, Richard W. Crowley (USMC-Ret.), her parents and her brother, Richard E. Lundberg.
