GEORGE ADELMANN, JR.

WHEREAS, George Adelman, Jr., of Wharton,, New Jersey, formerly of Roseland, New Jersey, is being remembered upon his passing from this life on Friday, March 3, 2023, at the age of 79; and

WHEREAS, retired Roseland Police Chief George Adelman, Jr., affectionately called "Corky" by friends and family, was born in Newark, New Jersey, on September 14, 1943. He graduated from West Caldwell High School in 1961; and

WHEREAS, George Adelman, Jr., worked as a plumber's assistant, in a warehouse, and as a stock clerk. He boosted his draft and was drafted into the U.S. Army on July 11, 1964. After attending many training schools, he became a qualified paratrooper and was assigned to the 82nd Airborne in Fort Bragg, North Carolina. He was trained for the Military Police and was granted secret clearance. In 1965, he was deployed to the Dominican Republic crisis. He was a member of the Veterans of Foreign Wars, Roseland Post 2619; and

WHEREAS, having already taken the Roseland Police Department exam, George Adelman, Jr., began the Essex County Police Academy on September 20, 1965. While a member of the department, he attended many police training schools. He rose through the ranks, from Patrolman to Sergeant, Juvenile Aid Officer, Detective, Detective Sergeant, Lieutenant, Captain, Acting Chief, and finally became Chief of Police. Having served over 35-years with the department, he retired in January 2001. He also owned and operated a house painting business for 27-years as a side job; and

WHEREAS, George Adelman, Jr., was the beloved husband of 56-years to Karen; loving father of Thomas Adelman, and his wife, Jennifer, Michelle Adelman-Bennett, and her husband, Brian, BonnieLynn Adelman, and her husband, Peter; cherished grandfather of Jerod Adelman, Meadow and Brooke Doerr, and Ryker and Willow Petito; dear brother of the late Herbert Bachmann. He was predeceased by his parents, George Adelman, Sr., and Winifred Smejkal; now, therefore, be it

RESOLVED, that the Essex County Board of County Commissioners hereby celebrates the life and mourns the passing of George Adelman, Jr., and offers their heartfelt condolences to his family; and be it further
