WHEREAS, Europe Harmon of Newark, New Jersey, is being remembered upon his passing from this life on Sunday, February 5, 2023, at the age of 67; and

WHEREAS, Europe Harmon was the patriarch of his family and a pillar of strength who captivated everyone whose path he crossed, on screen and off; and

WHEREAS, Europe Harmon, a man of astonishing accomplishments, took greatest pride in bringing his beloved daughter Najaah Kaamilah Harmon into the world and nurturing her as "the crown jewel" of his life and "the impetus" behind his purpose – a daughter who, along with everyone else, can "Be and be better. For [he] existed," as Maya Angelou wrote; and

WHEREAS, Europe Harmon was preceded in death by his father Europe Armour; his sister Charlotte Dunson; and niece Jahkira Paterson. He leaves to cherish his precious memory his daughter Najaah, the apple of his eye; his "best friends" and movie partner grandchildren Thomas and Tori; his mother Willie May Harmon; his sisters Gwenette and Tiffany; his nephew JahQuan; and nieces Tia, Jene and Taylor; his wife, and numerous aunts, uncles, cousins, great nieces, great nephews and friends; now, therefore, be it
