RE: BUDGET INSERTION FOR THE 2022 LOCAL INFORMATION NETWORK COMMUNICATIONS SYSTEM (LINCS) FOR THE PERIOD BEGINNING JULY 1, 2022 AND ENDING JUNE 30, 2023 IN THE AMOUNT OF \$721,009, FOR THE ESSEX COUNTY HEALTH DEPARTMENT.

**INTRODUCTION**

The Essex County Health Department (Division of Community Health Services) is requesting approval of the budget insertion for the 2022 New Jersey Local Information Network Communications System (NJLINCS or LINCS) Grant Agreement. The New Jersey Department of Health has fully executed the original agreement dated December 21, 2022 between the County of Essex and the New Jersey Department of Health to organize, implement, and monitor programs and services.

The grant agreement to the County of Essex for the 2022 - 2023 grant period for operation of the LINCS Agency is \$721,009.

**RECOMMENDATION**

It is recommended that the Essex County Board of Commissioners approve the Grant Agreement for the 2022-2023 LINCS Agency grant continuation in the amount of \$721,009 for the period July 1, 2022 to June 30, 2023.

**REASON FOR RECOMMENDATION**

The insertion of this funding source will assist the Essex County Health Department with the expenses associated with various LINCS Agency requirements necessary to provide ongoing support, notification, and monitoring services for the residents of Essex County.
