Introduction:

Three Memorandums of Agreement's (MOA) were developed between the City of East Orange, Township of Irvington/Irvington Neighborhood Improvement Corporation and the Township of Montclair with the County of Essex, Department of Citizen Services, Division of Community Action for Code Blue Emergency Homeless Services not to exceed the amount of \$120,000.00.

The MOA is to provide funds to the City of East Orange, Township of Irvington/Irvington Neighborhood Improvement Corporation and Township of Montclair for the purposes of assisting the County during the Code Blue declaration to shelter homeless individuals and families when frigid and/or inclement weather conditions occur for the period of January 1, 2023, through March 30, 2023.

Recommendation:

It is recommended that the Essex County Board of County Commissioners approve these Memoranda of Agreements for the three (3) month term to ensure the homeless population is assisted with shelter accommodations as needed.

Reasons for Recommendations:

To assist the City of East Orange, Township of Irvington/Irvington Neighborhood Improvement Corporation, and the Township of Montclair in collaboration with the County of Essex' efforts to provide sheltering to the homeless population during the County's Code Blue declared dates.

Fiscal Impact:

The Memorandum of Agreement's shall not exceed \$120,000.00 and there is no match required for the funding. The grant is 100% funded through the Essex County Homeless Trust Fund grant; therefore, there is no negative fiscal impact on the County.

- Providing system management, monitoring and oversight.
- Maintaining a thorough, accurate, and updated resource database (NJHMIS)
- Collecting and disseminating community needs data, and
- Communicating and collaborating with partner agencies
- The receipt of invoices and the remittance of funds as they are available, and not to exceed any agreed upon and understood funding amounts.
- The ability to accept, request for changes to, deny, or request the reimbursement for any funds requested or utilized by the City of East Orange. The County at any time reserves the right to terminate this MOA upon its discretion, through written notice to the City of East Orange




